Introduction

There are a range of health & safety software systems being advertised to growers to help them manage their risks. Using a software system to manage health & safety is not a requirement but some growers may find it a useful tool. To help growers understand the systems available, NZKGI engaged BECA to complete a review of health & safety software providers. This review has been completed against a set of requirements identified by kiwifruit industry representatives.

BECA reviewed 12 health & safety software products currently available in New Zealand. Each product was reviewed, and capabilities discussed with providers.

System requirements/capabilities

Kiwifruit industry representatives from throughout the supply chain met and discussed features that could be included in a software product and the importance of these. The following capabilities/features were identified as important for the industry:

- On-boarding process
- Contractor induction process
- Easy to use incident, near-miss and hazard reporting for all users including contractors
- · Editable mapping options
- Geo-gating/geo-fencing
- Online/offline capability access to the system either via web based or App system. The system should be functional when utilised offline with no connectivity, however would automatically update to the main database when online again.
- It is preferred that the software system is compatible with other software programs such as geo-mapping programs.

Recommendation

A specific recommendation has not been made as to which product should be used. This is a comparison of the capability of 12 software programmes against certain criteria.

This comparison table is intended to be a tool to help inform kiwifruit growers in their decision making should they choose to utilise a health & safety software system.

Explanation of features/capabilities

On-boarding

The process to ensure customers are familiar with the health & safety software to ensure they have the necessary knowledge and skills to effectively utilise the tool in their business. On-boarding could include but is not limited to face-to-face training, webinars, access to online resources and/or FAQ's.

Health & Safety

Health & safety related features of the software which can be utilised by a business to report incidents, register hazards, upload health & safety management systems and/or receive health & safety advisory services.

Contractor Management

The contractor management feature allows for a prequalification process that tracks the currency of insurance certificates and training records of the contractor. Contractor induction allows for a visitor to an orchard to be inducted prior to accessing the site. This should ideally include a mandatory review of the hazard register before completing the induction process, along with a sign off (tick or signature) to indicate that the inductee understands the risks, and terms and conditions of entry onto the site. This would also require a hazard register to be uploaded or generated within the software system.

Interactive Features

Geogating/fencing capability allows a grower to be notified as a person enters and exits the orchard. A mapping feature allows a user to view a map of the orchard on the software.

Compliance

The software will enable compliance with part of the Health & Safety at Work Act 2015 and record completed audits.

Training

The ability to upload records of training courses and certificates completed by employees in the system.

Reporting

The ability for the software to run a report from stored data parameters, including incident and hazard reporting.

Cost

General costing of the product as per the following key:
