Whakatāne, like other districts, faces significant challenges over the next few decades. The decisions we make today will have intergenerational impacts. We need clear sighted and far sighted leadership to support our communities to not just survive but to thrive in these challenging times. I bring proven and effective leadership, and open and accountable approach, and I work for all our communities. How I will support the kiwifruit industry is by ensuring that you have good, clear information from council and planning processes that protect valuable soils and support good land use.

Q5. What is your view on the growth of kiwifruit in your region, in respect to urbanisation, protection of productive land and environmental pressures?

Kiwifruit is growing in our sub-region and bringing high value hort to the district. We do need to protect productive land (as we are doing with our spatial planning at the moment) and I don't see this as incompatible with the needs for housing growth that we are experiencing. We do need to advocate for a better tranport network to make sure that produce from the East Coast has a good route to markets, especially the port in Tauranga.

Q6. Given the decision to include the value of the SunGold licence in the rateable value of a property and therefore significantly increasing rates for many kiwifruit growers. Do you agree with this decision? How do you propose to ensure that rates are equitably calculated and applied?

I'm aware of the test case in Gisborne and the High Court decision. Whakatāne has not discussed the option of including the value of SunGold licenses in the rateable value of properties and at this stage there is no proposal to do so, to the best of my knowledge.

We are conducting a spatial plan for the Eastern Bay which will look at how to best provide for housing needs, among other things.

Q8. Access to water for kiwifruit growers is becoming more critical. How would you promote balanced discussions with stakeholders regarding water supply and policy that reflects the significant value of the kiwifruit industry in your region?

Water allocation is a matter for the regional council, but highly constrained by legislation. I personally support a review of allocation rules that provides for the most economic use of that proportion of the water that can be taken without adversely affecting ecosystem health and social and cultural values.
