I hereby declare the final results of the 2023 Annual General Meeting voting, which was held on Wednesday, 23 August 2023, as follows:

Resolution 1 - Previous Minutes

That the recommendations of the Remuneration Committee be approved with effect from 1 January 2024.

As 91.69% of the weighted votes recorded for Resolution 5 voted I AGREE, I declare Resolution 5 carried.

The voting return percentage was 8.61% by growers and 15.84% by production, being 224 growers.
