Q4. What will you do to support the development of seasonal worker housing, especially in rural areas?

I would support streamline housing for growers and fit for purpose accomodation on or near orchards. Seasonal workers are essential to our horticulture sector, particularly in rural Northland, and providing secure, affordable housing close to workplaces benefits both the workers and the growers. Supporting this development also eases pressure on local rental markets and strengthens rural communities.

Q5. How will you ensure kiwifruit growers have reliable access to water, and how will you balance competi ng demands?

Ensuring that the source is sustainable would be my first thing to do, if its irrigated waters than ensuring that the bore reports have been done and if not why not? These reports should be held by operations. From that point id then be looking at where and if there is another source that could be accessible then work through the resorce consenting process with the applicant.

I'll back smarter water storage, fair allocation, and efficient use-so kiwifruit growers have reliable access while balancing the needs of households, the environment, and other industries.

We need to ensure productive land isnt swallowed by the urban sprawl and subdivision or it will cause great loss in jobs and revenue to northland.

This means fixing potholes and slips quickly, strengthening bridges for freight loads, and future-proofing roads against flooding and erosion. I'll also work with councils, Waka Kotahi, and local growers to prioritise the routes most vital to our horticulture and farming economy. Better roads mean lower transport costs, safer communities, and more reliable access to markets for our growers.
